The College will be sending electronic reminders closer to October.

Fern Hubbard, Registrar, is planning liaison sessions over the summer to hear from registrants about workplace barriers that limit the services dietitians provide. She will also be meeting with employers, administrators, other regulatory colleges, educators, Dietitians of Canada and the Ministry of Health. To date, registrant liaison sessions are planned for June 11 in Victoria, June 12 in Kamloops and June 13 in Kelowna. Amendments to the Health Professions Act have been presented to government as the Health Professions (Regulatory Reform) Act. The new Act contains **significant amendments** that impact all health regulatory colleges. Once passed into law, they will be incorporated into CDBC processes and summarized for registrants.
